A Sierra Club Foundation DAF lets you coordinate your charitable environmental activity through one vehicle. You can take a tax deduction for your gift immediately and take your time deciding which organizations to recommend for grants. You gain access to environmental leaders with national and global networks to help you make more informed philanthropic decisions.

Further, your DAF assets become part of the Foundation's professionally managed \$100 million portfolio, which adheres to strict mission-aligned investment guidelines. So while you are deciding on your grant recommendations, you can rest assured that your assets are invested in a manner that reflects and supports your environmental values.

Participating in Sierra Club Foundation's DAF program can bring sharper focus to your environmental giving goals. Compared to what you might achieve by establishing a private foundation, a DAF may offer greater flexibility and agility, as well as preferable tax treatment, with less administrative burden and cost.

TERMS & FEES

- Minimum contribution amounts: Initial - \$100,000. Subsequent - \$10,000
- 25% of all contributions must be designated to Sierra Club charitable programs fiscally sponsored by the Sierra Club Foundation or to Sierra Club Foundation charitable grant programs
- Minimum grant amount: \$2,500 to U.S. organizations; \$10,000 to non-U.S. organizations for qualifying charitable purposes
- No annual pay-out requirement, but active use of your DAF is strongly encouraged
- Administrative fee: 1% of the balance of the Fund, assessed annually on December 31
